NOTICE OF RACE

ORGANISING AUTHORITY / RULES

The organising authority is GYGSC The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.

ELIGIBILITY AND ENTRY

This is a 2 day event, Open to all Solutions and Phantoms
Entries by persons under 18 years of age must be countersigned by their parent or guardian

FEES

Required fees are: £40

SCHEDULE

Registration: will take place in the clubhouse on Saturday morning from 10am

Briefing: will take place on Saturday morning at 1130am for all competitors

There will be separate starts for the Solutions and Phantoms

The event will be a six race series held over two days.

The first start will be at 1300 on Saturday and 1030am on Sunday.

SAILING INSTRUCTIONS

The sailing instructions will be available at Registration.

VENUE

The venue will be GYGSC, Harbour Mouth, Gorleston on Sea, NR31 6PL.

THE COURSES

Courses will be as shown in the sailing instructions

SCORING

- (a) When fewer than three races have been completed, a boat series score will be the total of her race scores.
- (b) When three or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

PRIZES

Prize giving will take place in the clubhouse within 2 hour of the last race finishing

RISK STATEMENT

Rule 4 of the Racing Rules of Sailing states "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone".

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees & acknowledges that:

- (a). They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event
- (b). They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore.
- (c). They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- (d). Their boat is in good order, equipped to sail in the event and they are fit to participate; (e). The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
- (f). The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;
- (g). It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event.

INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of £3,000,000 per incident or the equivalent.
